TREASURER'S REPORT

Richard reviewed the December 2021 Financial Statement:

 of this date \$28,750.00 has been received and deposited; \$2,750.00 had just been received and is ready to be
 deposited. Dues for 66 lots have not yet been received.
- Budget Overview and Discussion
 - The proposed Budget was presented and discussed. A few questions were asked and adjustments were made. Richard will incorporate those into a revision to be presented at the February meeting.

COMMON AREA REPORT

Pete reported that everything looks good at both Common Areas but that the rocks dumped at the gap at the launch ramp in Common Area 1 had not fixed the problem. Denny and Richard will look into this and try to remedy the situation.

Denny stated that a resident had brought to his attention that the ramp to access pier 2 has a "lip" to it where it meets the grass making it inaccessible for the wheelchair of the person who has a boat slip on that pier. The Board discussed ways to fix this and will make the adjustment as soon as possible.

Richard reported that he has purchased new life rings and fire extinguishers in both Common Areas and that they have replaced the old ones.

The Board discussed the reconstruction of pier 3 and the possibility of shifting pier 3 over to the left about 2 feet. Denny said he would call Peery Agee to have him review the area and determine if this was possible.
