OLD BUSINESS

Life Ring Installation

- Denny installed life rings but should ropes to secure be attached to the rings so that if a ring is thrown it can be easily retrieved?
 - Paul agreed, Denny will follow up with Meghan to find out where they were ordered from so the Board can get appropriate ropes to knot to the life rings
- Pete reached out to the owners of the boat with tree growing in it, no contact made yet

Reconstruction of Pier 4/7

Denny met with Justin (WH Construction). Denny found out that the docks can only go out 150 ft. into the water from the shore line. Donnie suggested maybe a special permit to go further? Pier 7 can go further than 4 but water depth is a major concern. The added water depth could mean those with free-standing lifts might not be able to adequately reinstall the lifts. Justin is available in spring or fall of 2024.

After some discussion it was decided by Paul and Denny that fall 2024 would be better as the Board will have to hold a meeting with all slip owners well prior to the start of construction. Denny and Justin

recommended starting with pier 7 as it is the older of the piers and in worst shape; Paul agreed. The Board discussed reconstruction of pier 4 for 2025.

Paul suggested hiring a professional engineer to see if he/she could give recommendations on how the extended length of pier 7 might impact the slips. Denny said he had been given the name of someone, from Justin, and would give her a call.

Regarding the possibility of deeper water for some of the slips and the possible inability to reinstall freestanding lifts, a resident recommended hydraulic lifts. Paul tossed out the idea of an L shape dock

Denny recommended including, in that message, that with the new electronic gates, people need to assume that anyone using the common areas either live here, are renting here, or are guests of residents.
