Fenced in dog area was discussed and were different variables brought up from The Board and residents in attendance. The main concerns were that this would create clean-up issues for residents, as well as insurance for animals being on the loose. Paul Motioned for Vote, Eddie seconded the Motion, and it was voted not to move forward with a fenced in dog area in Common Area 2.

Denny brought up the recent tar jobs being done in the neighborhood, suggested to Paul that we call VDOT. Paul brought up the fact that the roads are state maintained by VDOT and he can call but the more residents that call and complain it may help get VDOT to do something about the poorly done job as the BOD has no direct input.

Donnie brought short-term rentals up as it's been a hot topic lately around Lake Anna. Over half of the properties not only in Cuckoo's Nest but also in the surrounding Lake Anna area are rental properties. He advised the county is considering making attorneys necessary in the involvement of short-term rentals and that there is a concern with Air BnB's on the lake. There is a business involvement aspect to it as well because if the lot is not zoned as commercial, they cannot run a business out of their home like an Air BnB.

Denny advised that the County is having a meeting to discuss short-term rentals with the Planning Commission on September 14th and some of our residents may be interested in attending since this would affect their rental properties.
