### **Old Business**

### **New Business**

The Commons Area Capital Improvement committee will investigate prices and options for extending the Common Area I ramp. Pete McKenney will get a sign to warn users on low water and if necessary the ramp closed will be closed for safety.

Greg Phipps will update us on signs for addressing state guidelines for fishing, boating alcohol at the next meeting.

Bill Stevens will contact the mowing company for the contract pricing for next year. The contact will be reviewed at the next meeting.

Pete McKenney will lock port-a-potties as instructed by Dominion.

A concern was brought to the board about ATV issues on private property. The board appreciates the problem presented however due to the issue occurring on private property there is no action the board can take.

Tim Coleman will e-mail the board the HOA invoice letter to review for the next meeting.

Jessica Escobar will head up the nominating committee. Tim Coleman will post the information on the web.
