#### YOUR ANNUAL DUES AT WORK

The Annual Dues you pay each year are an important and necessary part of maintaining the Common Areas used by residents/lot owners and guests of the Cuckoo's Nest Subdivision.

When the subdivision was created, the developer knew that once he/she was no longer overseeing the subdivision there would be a need to continuously monitor and maintain the amenities; thus an Association Board was created. These amenities require funds for constant maintenance and upkeep as well as future replacement as they age. The State of Virginia requires that Associations (POAs and HOAs) abide by the state's rules and regulations. One of those is to maintain funds for replacement of major structures within the subdivision. This savings fund is called a Reserve Fund. HOAs and POAs are required to have a triennial assessment by an independent organization reviewing and outlining the funds needed to maintain the appropriate Reserve Fund. The amount suggested to be maintained in this fund is determined by the age and number of structures within the division. In addition to this Fund, there are Operating Expenses incurred for day-to-day upkeep and maintenance of the Common Areas (i.e., lawn mowing, portable toilets, etc.). Unlike many other subdivisions Cuckoo's Nest has not only one Common Area but two! The Board works diligently each year to create a budget that fulfills all of these needs with only the income from the annual dues received from residents/lot owners.

So please remember, when writing and mailing your annual dues payment, you are helping to maintain the community in which you directly live and play. We can all be thankful to each and everyone of our neighbors for working together to preserve a beautiful and safe place to live.

#### CUCKOO'S NEST HALLOWEEN FUN NIGHT

On Saturday, October 26, 2019, Cuckoo's Nest held the first Trick-or-Treat event for the younger members of our community. As this was the first time for this event, attendance of residents handing out candy and children receiving candy were minimal but those who participated had a great time! ### COMMON AREA PARKING

As a community we can all help to maintain the integrity and usefulness of our common areas by remembering to park vehicles in the designated parking areas.

In Common Area II, only golf carts and utility vehicles are permitted to drive on the grass areas and park near the new covered docks. All other vehicles must be parked in the designated parking area. Please refrain from driving cars and trucks on the grassy area. These larger vehicles can damage the grass and soil. Your cooperation in adhering to the posted signs is greatly appreciated by all who use and maintain these areas.

### **COMMON AREA GUEST PARKING**

Parking Passes are no longer needed for residents' guests parking in the Common Areas. This is due to the fact that guests can only access the Common Areas by vehicle with the assistance of the resident/lot owner. # LOCK COMBINATION IN CASE OF GATE FAILURE

In the case of an <u>extended</u> power failure to the gate, the gate will be secured with a combination lock. This combination will not be changed year-to-year since this type of lock will only be used in extenuating circumstances.

# COMMON AREAS I AND II DOCK REPLACEMENT INFORMATION

## **UPDATE**

Last Fall the CNA Board contacted eight contractors for estimates for replacement of the launch pier and dock(s) in Common Area I. In February 2020, after much discussion and review, the Board narrowed the list down to three contractors. To ensure all the requirements are met, a Board member was named as the Project Manager to oversee the project. The information below outlines the responsibility of residents/lot owners affected by this project;. As soon as a build date has been established, letters will be mailed to those residents/lot owners who will be directly affected by this first phase of a long-range plan to replace the aging docks in Common Areas I and II.

#### INFORMATION FROM SUMMER/FALL 2019 NEWSLETTER

For the past several months the CNA Board has been reviewing whether to repair the damaged dock in Common Area I or move forward with the Reserve Study advisement that docks 1 and 2 in Common Area I be replaced in 2020. After reviewing options the BOD voted to begin the replacement of the docks instead of paying to repair now then pay again to replace in just a few months. As docks are replaced lot owners/residents are advised that any enhancements that have been added at these docks (i.e., lifts, solar cells, etc.), by a lot owner/resident, are the responsibility of the lot owner/resident. Cuckoo's Nest Association is responsible for the docks only. As these docks need to be replaced, it is the lot owner's/resident's responsibility to have any lift or other enhancement removed prior to the demolition of the old dock. If the enhancement is to be reinstalled, the reinstallation is the responsibility of the lot owner/resident. Residents will be notified, as soon as possible, in advance of the beginning of the project, to make arrangements to have any enhancements removed. Any enhancement not removed before the beginning of the project will be removed by the contractor and that cost will be billed to the lot owner/resident. Also, all boats housed within slips of a dock being replaced will need to be relocated before the dock replacement project begins.

The Board realizes there is some inconvenience to lot owners/residents regarding this type of project but know that the safety and reliability of these docks is of utmost concern to everyone involved. Your cooperation and patience is appreciated as the first phase of this project is being reviewed and will hopefully begin sometime December 2019 to January 2020.

Information regarding dock replacement construction dates will be on the Cuckoo's Nest Association website.

**BOARD MEETING INFO** 

All Monthly Board meetings are open to attendance by residents/lot owners. Board meetings are scheduled on the second Saturday of each month; however, due to extenuating circumstances and holidays, these meetings may be rescheduled for other Saturdays. Please check the website before attending a meeting to ensure you have the correct date, time, and location. Several months throughout the year or due to bad weather, meetings will be held at the home of a Board member. Please be assured, residents/lot owners are still invited and very welcome to attend.

#### **BYLAWS REVISION**

As mentioned in the President's message, the Board has been working on a revision of the Bylaws. This revision is meant to clarify and specify information that is somewhat ambiguous in the original version. The intent is to ensure that residents/lot owners have a better understanding of the regulations associated with the Cuckoo's Nest Subdivision as well as their responsibilities as members of the Association and, in addition, to bring the Bylaws current with Code of Virginia Title 55, Chapter 26.

The Bylaws revision has been completed; however, when it was taken to be registered at the Louisa County Courthouse the Board was told they do not record Bylaws. Since the original Bylaws were recorded at the Courthouse at the inception of the Association, the Board wants to ensure the revised version is also at the Courthouse. Once this has been settled the revised copy will be posted on the CNA website.
